
Deed

Know all men by these presents that the Hawaiian Kingdom Trust Company, a general partnership established and existing under and by virtue of the laws of the Hawaiian Kingdom and registered by "Deed of General Partnership" as doc. #96-000263, and doing business at 850 Richards St., Suite 600, Honolulu, Island of O'ahu, hereinafter referred to as the grantor, and David Keanu Sai, appointed Regent of the Hawaiian Kingdom, hereinafter referred to as the grantee and in accordance with the provisions of the trust, in consideration of one dollar to it paid by said grantee, the receipt whereof is hereby acknowledged, does hereby remise, release and forever quitclaim unto the same, its successors and assigns all of its right, title and interest acquired by certain deeds of trust, namely, document no. 96-000664, 96-004246, 96-006277, 96-014116, 96-026387, 96-026388, 96-028714, 96-024845, 96-032930, 96-044551, 96-044550, 96-047382, 96-047380, 96-047379, 96-047381, 96-056981, 96-052727, 96-060519, 96-032728, 96-057667, 96-057668, 96-060520, 96-061209, 96-061207, 96-056980, 96-052729, 96-063384, 96-063385, 96-063382, 96-057664, 96-019923, 96-046712, 96-063386, 96-063382, 96-063383, 96-066996, 96-061208, 96-046711; To have and to hold with the appurtenances to said grantee, its heirs, successors and assigns forever, under the exclusive authority and jurisdiction of the Hawaiian Kingdom government. It is upon this conveyance that the Hawaiian Kingdom Trust Company shall be dissolved on the 30th day of June, A.D. 1996, in accordance with the provisions of said trust

And it is further understood that due to the requirements of United States law which stands in contravention to Hawaiian Kingdom law, a notary public commissioned by the same is required for registering this deed in the Kingdom's Bureau of Conveyances, I do this involuntarily and against my will.


